To update your email, simply notify CUNJ at [memberservices@cunj.org](mailto:memberservices@cunj.org). Paper copies of past statements are available by contacting CUNJ. There is a \$5 fee per statement copy for statements older than 6 months. Members are able to print statements through e-Banking using Internet Explorer for free. To view your statements, you will need to use Adobe Acrobat Reader. This software can be downloaded for free by visiting [www.adobe.com](http://www.adobe.com). Statement copies can be downloaded to your PC with 1 MB of storage space. You may change your statement options at any time. You will not receive paper statements in the mail unless you choose the option below.

These accounts will not contain telemarketing, cross-marketing, solicitation, advertising, or debt collection messages of any kind. The contacts will be concise and limited in frequency as required by law. You will have the opportunity to opt-out of such communications at the time of delivery.

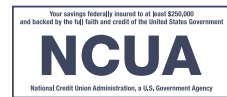
